Supreme Court hears McCleary update

Last week the Washington State Supreme Court heard arguments as to whether the state has complied with its mandate to fully fund public education. Network for Excellence in Washington Schools (NEWS), which is a coalition of school districts, civil rights groups, community organizations and education associations, argued the Legislature has failed to appropriate ample funding for education as required by the State Constitution. (Both LWSD and LWEA are members of NEWS.)

The State, on the other hand, declared they have achieved full implementation, full funding, and full compliance with the State Constitution.

Justices were focused on the failure of the state to fully fund teacher salaries. The original court decision required full state funding of teacher salaries by September 1, 2018. Legislators voted instead to phase in salary increases over 2018-19 and 2019-20. In Lake Washington, as much as one-third of teacher salaries are funded through local levy dollars.

The State's attorney, Alan Copsey, told the Court that the State could not be expected to provide such huge funding increases "all of a sudden." One justice shot back with a reminder that the McCleary case was decided by the Supreme Court in 2012.

NEWS attorney Tom Ahearne told the Court that K-12 funding falls far below the constitutional requirement under McCleary. The Legislature funded status quo for teacher salaries by only granting a cost-of-living increase this year. Also, the Legislature failed to come up with a construction budget to pay for reduced class sizes required by the McCleary decision.

NEWS asked the Court to impose more severe sanctions that would compel the Legislature to invest more money in K-12 public education. While the Court gave no indication of how it might rule, most observers believe a ruling will occur before the end of December.

Pool amounts set

Each year after the close of the open enrollment period for health benefits, the Business Office calculates the amount of the insurance pool. This year the Legislature has allocated \$820 per FTE employee to be used for benefits. State law requires that after everyone has made their basic benefits selections, any leftover money must go into an insurance pool. This pool is used to help full-time employees who have to pay part of the medical premiums out-of-pocket due to insuring their dependents. (The pool is not available to part-time employees.)

The amount available from the pool has been calculated. Teachers will be able to spend up to \$798 per month (\$823 if you are on Willamette Dental instead of Delta Dental) for their medical insurance after all of their other benefits have been paid. Selection of medical coverage in excess of this amount will result in a deduction from the employee's paycheck. These changes will be effective with the October payroll.

Keep in mind that under state law, school districts must set a minimum monthly medical benefit contribution that employees must make. We've negotiated that minimum to be \$10 per month.
